<b>What is the overall <a href="#">deductible</a>?</b>	For <a href="#">network providers</a> \$1,600 individual / \$3,200 family; for <a href="#">out-of-network providers</a> \$3,200 individual / \$6,400 family.	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. In-network breastfeeding support and most <a href="#">preventive care</a> , as well as in and out of network value drugs and breastfeeding supplies, are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply.
